

Once again we thank you for your participation in our last reunion in México. We are now asking participants to send a complete summary of their papers so they may be included in the publication of the CLAG-2005 Morelia Memoirs, this in order to achieve a finished product which would include all theoretical and methodological proposals, as well as all Latin American case studies presented.

We will receive all works which presented at CLAG-2005 Morelia last October, as long as they are adjusted to the required format included in an attachment to this e-mail, and are received within the established deadline. All papers will be submitted to external peer-reviewing.

The following is a general schedule for the process:

March 30 - Deadline for receiving summaries. These are delivered to peer-reviewers.

April 28 - Final peer-reviewing results. Delivery of accepted summaries to authors for corrections.

May 12 - Deadline for authors to return corrected summaries. Editors begin work on the publication.

June 16 - The complete document is presented for editorial review.

September 11 - Final version of the book. From this point on timing depends on the publishers.

3) My Community, Our Earth (MyCOE) Watershed Initiative Launches Regional Focus

To involve undergraduate students in local community projects, the MyCOE Partnership is launching a focused set of activities on issues of natural resource and watershed management in the Gulf of Mexico / Greater Caribbean Basin. With grants from the U.S. Department of Agriculture, the U.S. Agency for International Development and with support from the U.S. Geological Survey, the AAG will manage the new partnership initiative beginning with pilot sites in Puerto Rico, the U.S. Gulf States of Texas, Louisiana, Mississippi, Alabama, and Florida; and international sites in Honduras, Jamaica, and Panama. The goal of the program is to encourage and support undergraduates and their institutions to participate in using geographic tools and concepts for sustainable watershed management within local community projects. Linkages among the distributed pilot project universities, community organizations, and governmental agencies will include online networking, peer-to-peer mentoring, and a meeting to be held in the region that will showcase project results on sustainability. University departments, geography faculty, and undergraduate students interested in participating should send an email expression of interest along with a brief resume or CV to Dr. Patricia Solis, AAG via email, psolis@aag.org.
